AP2I was formed on May 1, 2020, to coincide with the commemoration of World Labor Day. The AP2I Forming Members are seafarers and people who have a high commitment and care about improving the welfare and protection of Indonesian seafarers.

Since its formation until now, AP2I has partnered with dozens of ship manning agencies in Indonesia through Collective Bargaining Agreements (CBA) and has more than 10,000 seafarers as members.

At the national level, AP2I is affiliated with the Confederation of Indonesian Trade Union Alliance Congresses (KASBI Confederation) and internationally, AP2I is affiliated with the World Federation of Trade Unions (WFTU).

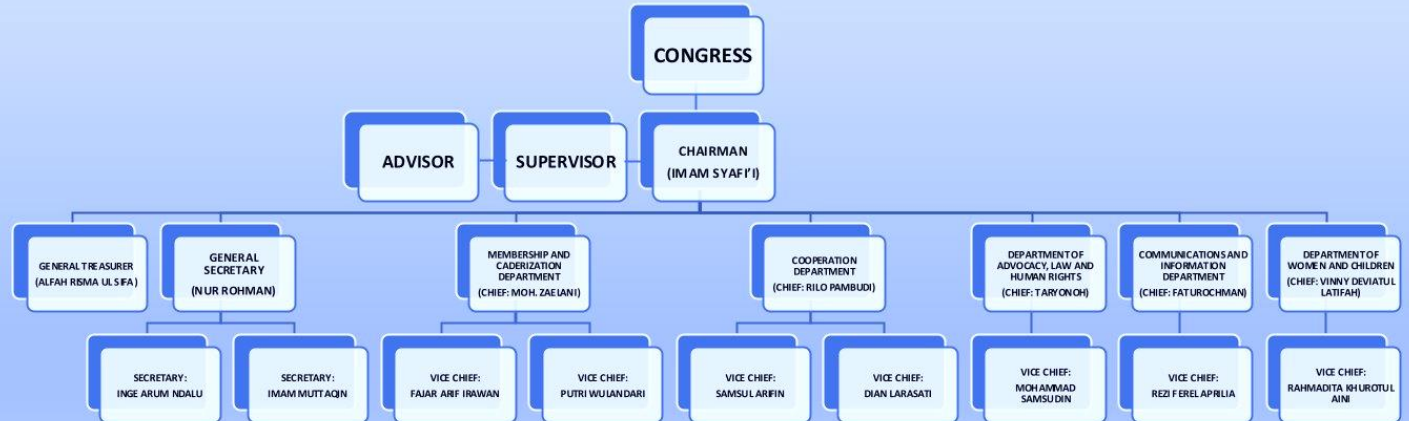

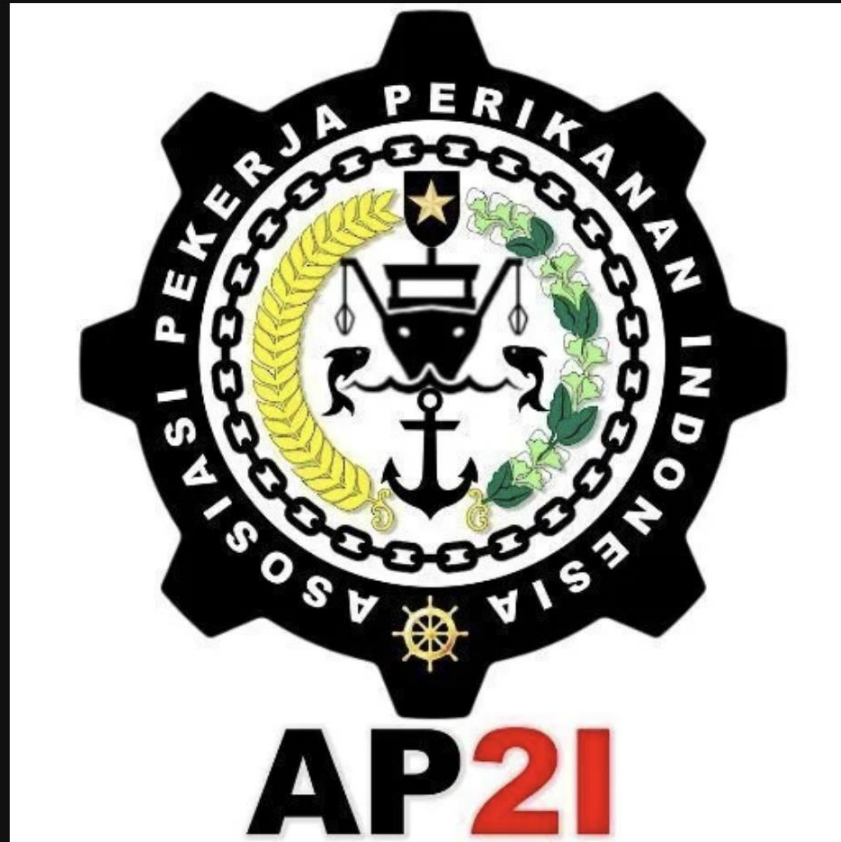

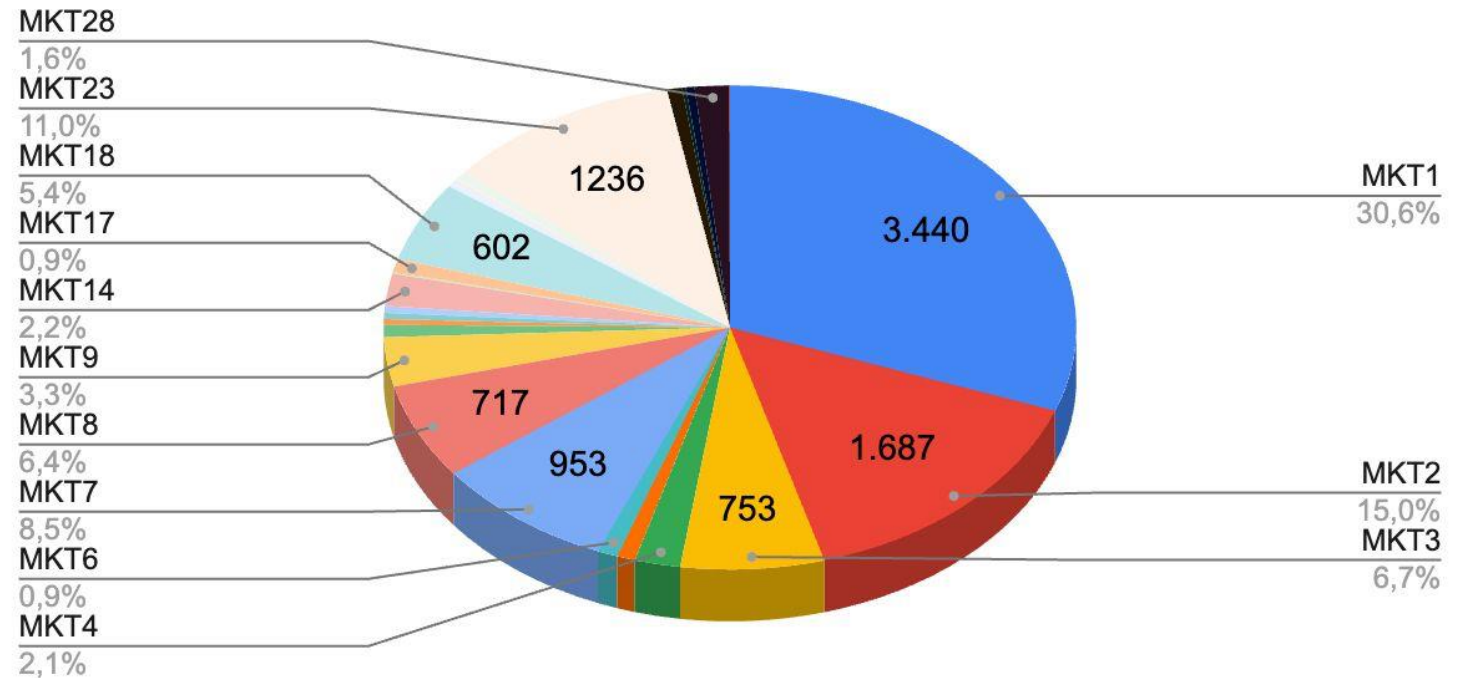

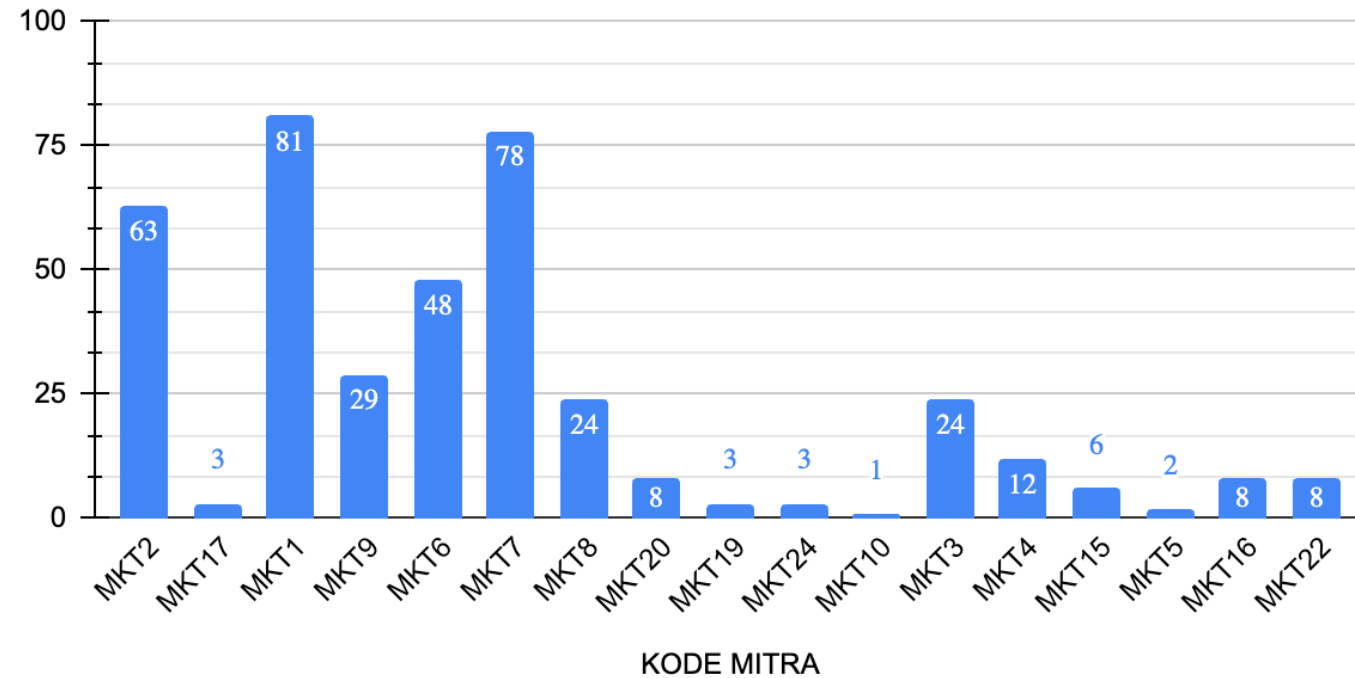

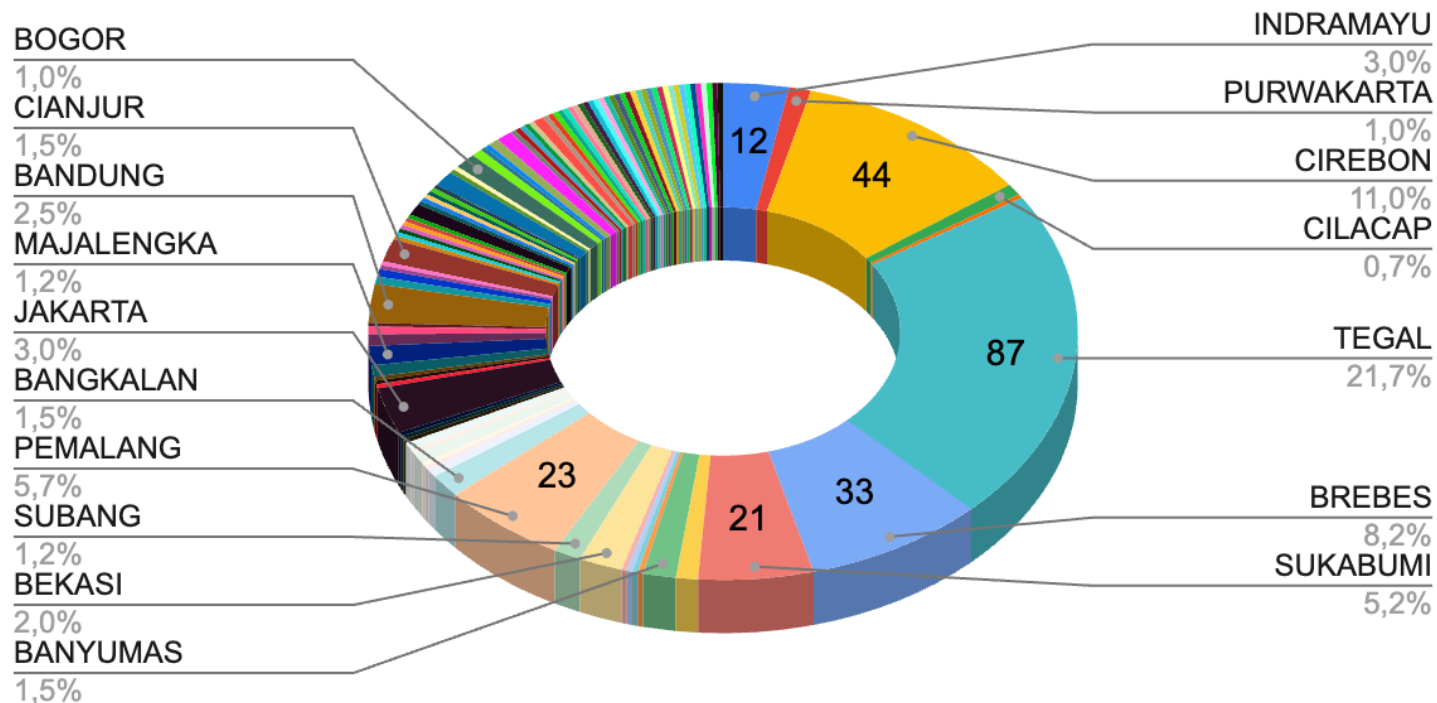

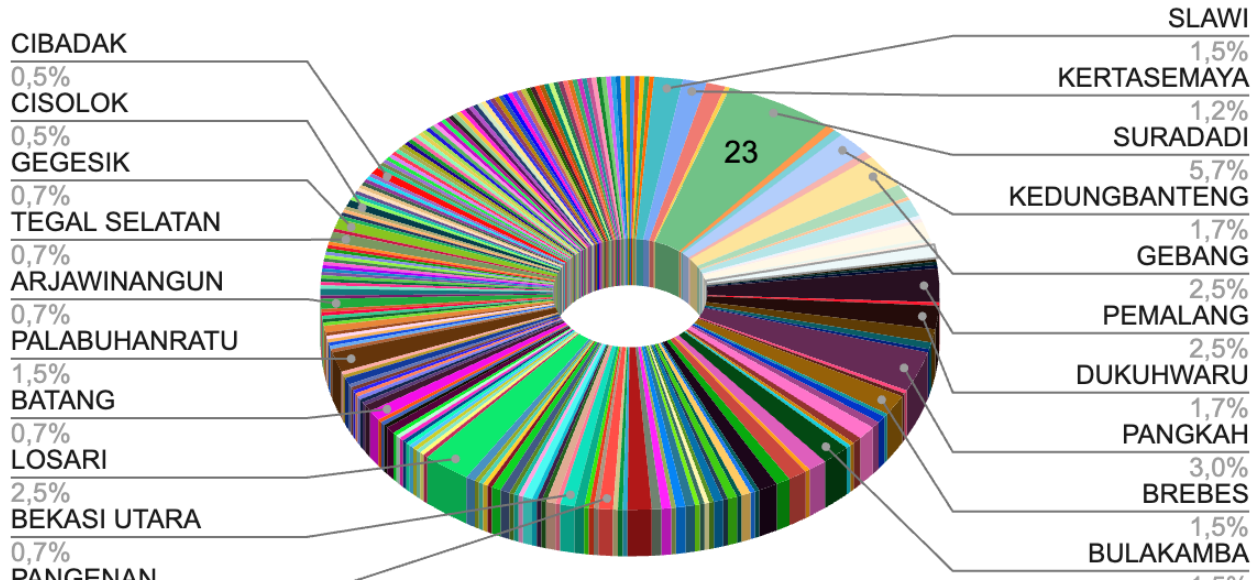

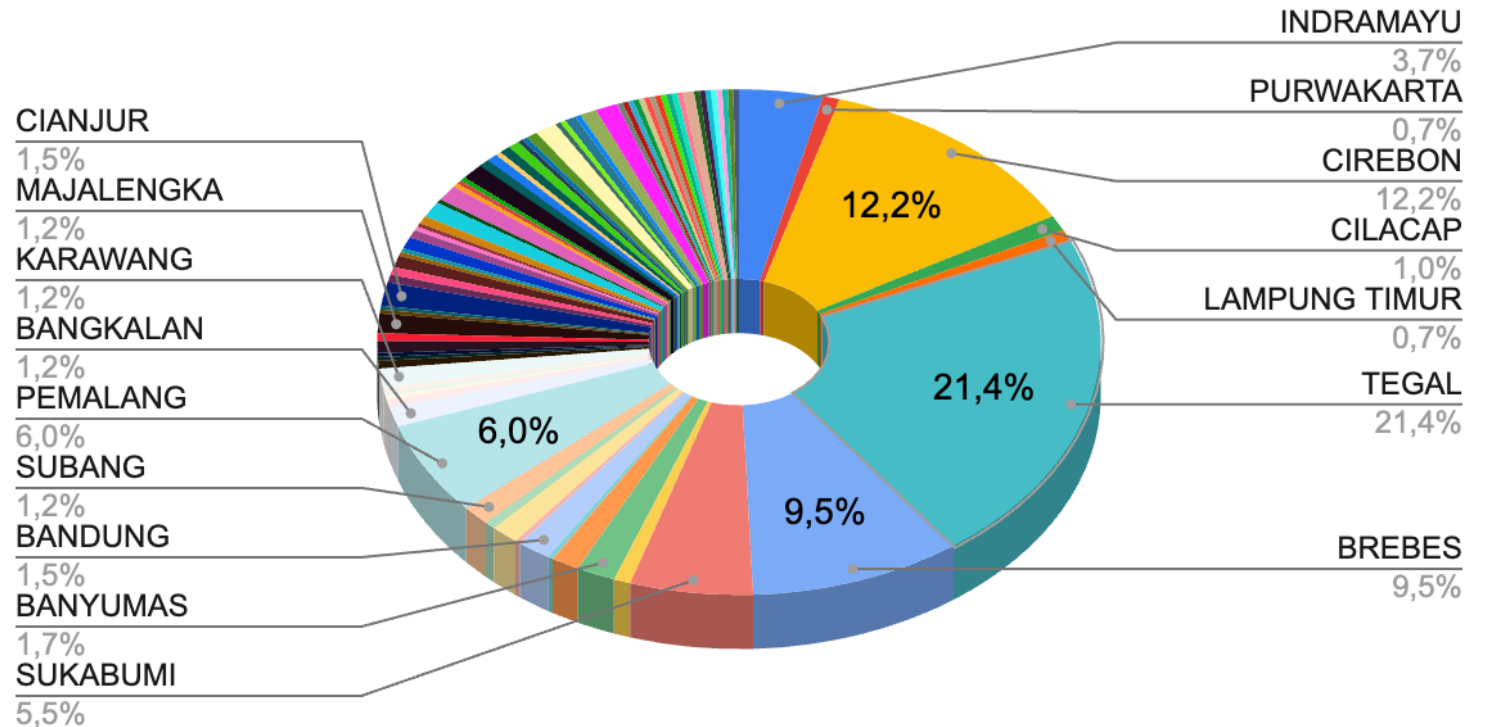

2025: 01 JAN - 21 MARET 2025= 401 ANGGOTA)**

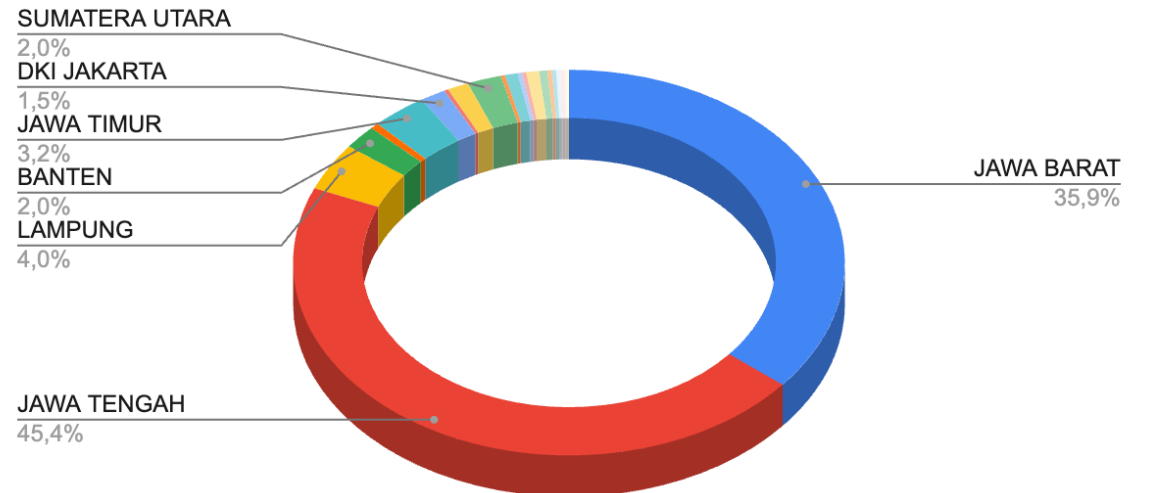

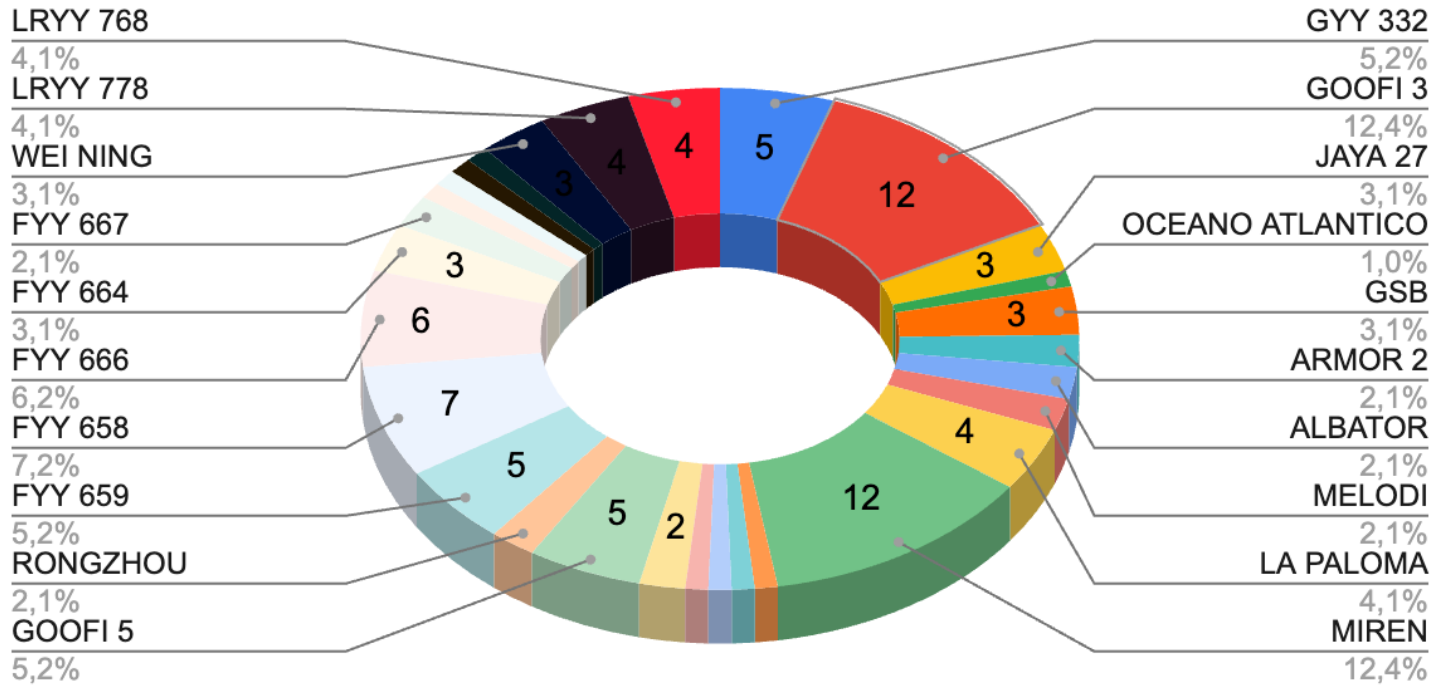
